### ***“What is the Worst Candy?” - P.T.’s Practical Theology***

What is the worst candy in the world? Is it “Circus Peanuts” or “Conversation Hearts”?

Gotta be.....circus peanuts! For the taste and texture, Circus Peanuts are not good at all!

But.....for the chalky taste and rock-hard texture, Conversation Hearts come in a close second!

Now, you may choose to disagree with my findings, and at any other time in the year, you might have a case. But as we enter the month of February, we can’t make Conversation Hearts the worst of all candies, because despite the chalky taste and hardness that can break a tooth....many of us do have a sentimental attachment to the Conversation Heart!

I suspect that I am not the only one who vividly remembers dumping out that box into my hand, to be able to sift through the ones that had just the right saying to be given to just the right person. “Cool Cat” might be given to your good buddy.....but, not “Crazy for You”! For that cute kid that sat behind you in homeroom, maybe you could slip back a “Be Mine”, or an “I Luv U”. Or if you were really daring you could hand over a trio: “Be Mine”, “I Luv U” and a “Kiss Me”! (*never worked for me....but it's always good to hope!*)

Well, that sentimental luv of the Conversation Hearts must, at some point, mature into the love for which Christians must be known. I say, “must mature” because Christians are called to mirror the love of God that was commanded by Jesus Christ: *“love one another just as I have loved you”!* (John 13:34).

In a world that has such an affinity with throwing out the command to love.....we, as a people of faith, know by example what love is and what love is not. When Jesus showed love, he did not reduce his love to that of a conversation heart. No! Jesus showed love by seeing a person through the eyes of the divine.

He loved with a pure love and with pure intent as only God can do. And when he came upon one whom he loved, but also one who needed some correction, he didn't excuse or gloss over sin, but out of His love, he called out the sin, forgave the sin and then called for those whom he loved to live in accord with God.

As you know, Jesus' greatest display was prefaced in John 15:13 when he said to the disciples: "*Greater love has no one than this that someone lays down his life for his friends*". Now, that is the ultimate display of love, for which Christ would suffer, yet it was not the display of love that Jesus wanted his disciples to have to do, but still wanted them to be ready to do, if God so called.

So, we you remember your loved ones on St. Valentine's day with a call, a card or candy, also take a moment to offer up a prayer of thanksgiving and dedication to the one who loved you as no other, Jesus the Christ, love made manifest!

## **Annual Congregational Meeting Minutes**

Joann requested that the ALC Women continue to donate a minimum of \$20.00 to help with funeral expenses for any given year. Joanne also mentioned that Sharla Hamen is not the contact person for funerals and that she will check with Neda Ries to determine who the contact person is. Rhonda Karst volunteered to water flowers on an as-needed basis.

Sunday School Report: Brenda McKee Almos presented the Sunday School report which can be found in the Annual Report on Page #12. Brenda mentioned that they have closed out the camp financial fund and that Sunday school attendance is down compared to other years. A brief discussion was had by congregation members with no action taken at this time.

Youth Report: Brenda McKee Almos presented the Youth Financial report which can be found on Page #13 and #14 in the Annual Report. Brenda advised that Wednesday in the Word (morning mediation, prayers and a full breakfast for grades 7-12) was well received with good attendance. She also mentioned that the trip to Minneapolis to assist with Global Health Ministries was a good and productive learning experience for all who attended.

Audit Committee Report: Rod Fischer advised that the audit committee (Rod Fischer, Lynn Borer and Landon Vetter) had reviewed all financial reports and that no issues were found.

Nominating Committee Report: A discussion was started by Rod Fischer concerning nominations with the following results:

- Danny Davis agreed to serve a 2<sup>nd</sup> term on the Church Council.
- Rod Fischer nominated Joanne Fischer to serve on the Church Council and Joanne agreed to do so.
- Landon Vetter is coming off the Audit Committee and Phil Ruml agreed to fill this position.

Constitutional Change Vote:

President John and Pastor Tom presented the request from the North American Lutheran Church (NALC) for us to ratify the constitutional changes made at the 2025 Annual Convocation. That motion is found on page 16 in the Annual Report. Pastor Tom moved adoption, with a 2nd by Rod Fischer. MC.

Pastor Tom stated that according to our Congregational Constitution, we need to ratify the action we took at the 2025 Annual Meeting to change our Constitution Article 12.0Sc to read "The Church Council may enter into contracts for up to \$7,500 for items not included in the budget. Previously the amount was \$2,000. Pastor Tom moved the ratification, with a 2nd by Paula Grupe. MC.

Presentation of the 2026 Church Budget:

Treasurer Doug Strait & President Bucher presented the 2026 budget which can be found on Page # 17 of the Annual Report (on the back of the constitution ratification voting page which was not utilized). 
